

IP Protection

- Consider if you need to file in foreign countries.
- The rights conferred by most types of IP extend only on a national basis.
- Choose your strong markets and get protection.
- Costs vary from country to country.
- · Consider registering in countries that have weak IP laws.











IP Ownership

- Canadian Myth: the employer is automatically the owner of all the intellectual property created by its employees.
- Canadian Myth: the customer is automatically the owner of all the intellectual property created by its independent contractors.











IP Ownership

- To avoid the necessity of making legal arguments on whether the invention/work/IP is owned by you and is not disclosed get:
 - · an Employment Agreement or Services Agreement;
 - · an NDA; and
 - written policies on IP ownership and protection of confidential information.











IP Audits

- IP Audits help determine where the problem areas are while you are doing business inside and outside Canada.
- · A thorough IP Audit should:
 - 1. identify, catalogue and evaluate the IP
 - 2. review ownership issues and agreements
 - 3. identify encumbrances, claims and litigation

- Personal Information Protection and Electronic Documents Act, S.C. 2000, c. 5 (PIPEDA)
- Alberta's Personal Information Protection Act, S.A. 2003, c. P-6.5 (PIPA)
- B.C.'s Personal Information Protection Act, S.B.C. 2003, c. 63 (PIPA)
- Quebec's Act respecting the protection o personal information in the private sector,
 CQLR, c. P-39.1









PIPEDA-FIVE KEY POINTS

- PIPEDA applies even if your business isn't in Canada
- PIPEDA applies to the collection, use, and/or disclosure of personal information during a commercial transaction
 - · What is personal information?
 - What is a commercial transaction?
- PIPEDA requires meaningful consent-understanding the nature, purpose, and potential consequences
- Organizations cannot and should not retain personal information longer than absolutely necessary
- Security breach impose specific obligations depending on the circumstances

- Permanent Residence based Work Permits Start-Up Visa Program, Manitoba Provincial Nominee Program











How to Avoid Common Immigration Issues

- Prepare in advance of travel
- Understand and comply with COVID-19 travel restrictions/requirements
- When necessary, apply in advance for business visitor visa or work permit
- Travel with business visitor or work permit document package
- Seek assistance from a Canadian immigration lawyer
