

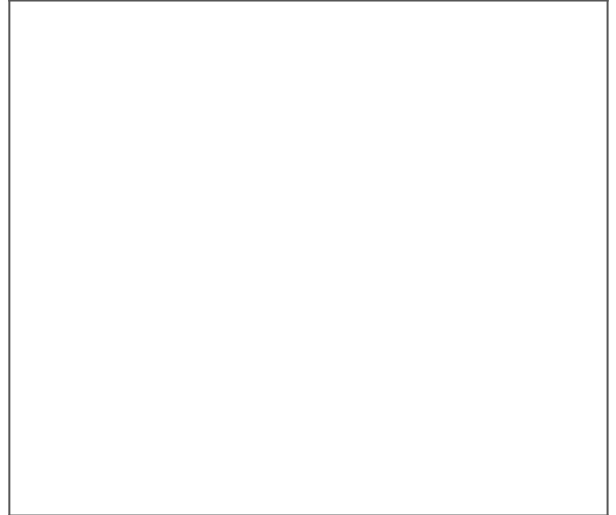
Sacha R. Paul a TDS Rising Star! Recognized as One of the Leading Lawyers Under 40 in Canada 2016
