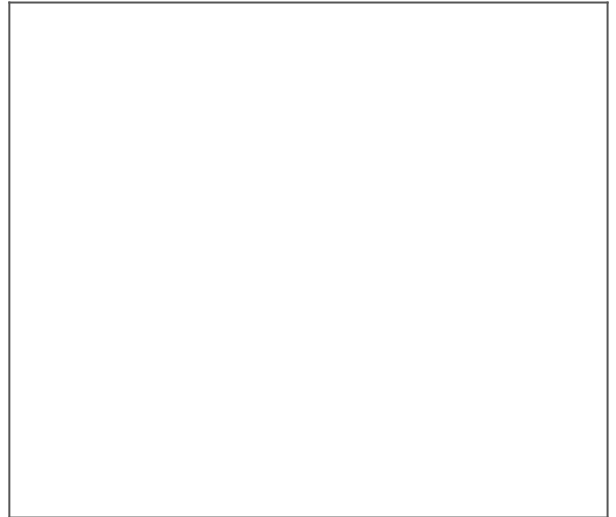
Previously, Allan was the Chief Executive Officer of The Law Society of Manitoba.
